Dumpper v.80.8 is a legal action that was filed on October 28, 2015 by an unknown plaintiff against the defendant, 80.8 LLC. The plaintiff asserts that the website of the defendant infringes on Dumpper's copyrighted material and represents unfair competition to its product of similar services with regard to price, quality, and quantity of goods or services offered for sale or distribution in interstate commerce. Both parties are currently seeking relief from the court of California for this particular dispute. It is unknown how this dispute will be settled, but the plaintiff is seeking damages for residual damages, attorney fees, and costs. The defendant is seeking a declaration of non-infringement or invalidity of copyright, an injunction against further infringement of Dumpper's copyrighted material, and all other requested relief that the court deems necessary to compensate for any losses they have suffered as a result of the defendant's actions.
